#### 01 Describe the work to be performed

- Conduct lifting operations on WesTrac sites in accordance with relevant Government and Worksafe regulations
- Provide tested, and compliant lifting machinery and rigging gear to facilitate the above
- Provide relevant licenced, trained and experienced personnel to facilitate the above
- To comply with ISO 9001:2008
- All other requirements per the Principal Scope of Works

#### **02** Extra requirements to the Pre-Qualification

- Subscribe to Crane Safe inspections for any cranes to be used on WesTrac Sites
- Inspection register for all lifting equipment to be used on WesTrac sites
- Record incidents and corrective actions in a suitable reporting system
- Provide copies of any lifting related Safe Work Procedures when completing work on WesTrac sites
- Provide copies of lifting plans when completing work on WesTrac sites
- Pre-starts for associated for mobile equipment
- A reporting system for defective machinery/issues found from pre-starts
- Certification of all registered/classified plant
- All other requirements per the Principal Scope of Works

- Any large discrepancies in cost to be scrutinised between both parties
